- All historic and non-historic lighting in Scotia are SCSD responsibility.
- All alleyways and Mill Lane in Scotia are SCSD responsibility.
- Winema Theater, Fireman's Park community forest, museum, baseball field, & soccer field are our assets under Parks & Rec.
- There are several capital improvement projects for the Parks Rec including but not limited to ADA upgrades and re-roofing of the theater.

- a. Receive a presentation form Jeff Land of Brandis Tallman on opportunities for debt restructuring and district improvement funding
- 1.17 million estimated cost for all the Capital Improvement Projects the SCSD is looking to complete.
- Interest rates have dropped since we last looked at this lender's opportunity (last February).
- Brandis Tallman is a municipal bond underwriting firm—they specialize in working with CSD's and public utility agencies.
- To provide funding up front for all of our improvement projects instead of trying to finance them one at a time.
- Public agencies are very limited in the types of funding they can pursue.
- Current term sheet for the SCSD is on the table so long as we are willing to have a banking relationship with Umpqua to the tune of a half million dollars.
- 6-8-week process to close financing of this nature once kick-off is initiated. A lease agreement and resolution to then be presented to the board which then locks in finance amount and interest rate.

- Is this type of finance similar to a mortgage?
- Jeff Land; no, it is not because our community service district is what is known as a debt limit entity under the California Constitution, in order for us to do any sort of finance you must structure it as a lease to counter party, specifically a non-profit. In this case the expected counter party is the California Special Districts Association (CSDA). Our facilities are put up as assets for collateral and lease that property to CSDA.

 - Morgan Dodson's 22 Trees Project update
 - Corridor Project (infrastructure replacement from the river intake to WTP) approximately 75% done.
 - Sand and silt are being pumped out of the river near the river pump so they can fully install the pump into the river gallery.

- Soccer field, we just received the agreement with Scotia Union School who will use the soccer field with no facility use fees in exchange for field maintenance.
- Rio Dell School is also in communication with us to set up a similar arrangement.
- Engaging with SHN to set up a pre-treatment program which would set our own limits for discharge into our wastewater system. This would give us the ability to monitor and enforce high BOD, TSS, or pH's coming from commercial entities and as well supports the effort of the splitting off of our NPDES permit.
- We missed the window for the SEARCH grant for this year, but will likely be getting the 30,000-grant for the next FY.
- Lead Abatement update; Fred Runner with Friends of No. 9 is hoping we will contract with DCI Builder's for repair of the county ADA sidewalk damaged by the crane removing the Heisler Engine from the Museum Plaza. He is also asserting that the lead levels are not their responsibility of Friends of No. 9, they were not above the legal threshold, and called into question the credentials of the engineering firm who conducted the sampling. (They are, actually).
- Working to hire a temp to help with the work load to take a few things off of the administrative workload while current staff is finishing degree requirements.
- Sherriff and adult services removed some illegal campers from the community forest that have been there for quite a long time. The individuals were then directed to the application process for the near completed special needs housing project in Rio Dell being constructed by Danco Builders for permanent supportive housing.
