A RESOLUTION OF THE SCOTIA COMMUNITY SERVICES DISTRICT BOARD OF DIRECTORS TO ADOPT THE MID-YEAR FISCAL YEAR 2020-2021 BUDGET AMENDMENT

WHEREAS, the Scotia Community Services District ("Scotia CSD") is organized and operates pursuant to the California Government Code Section 61000, et seq.; and

WHEREAS, the Scotia Community Services District operates on a Fiscal Year beginning on July 1, and ending on June 30, of each year; and

WHEREAS, the Scotia Community Services District Board of Directors is required by California Government Code Section 61110(f) to adopt a final budget on or before July 1st of each year; and

WHEREAS, the Final Budget for the Scotia Community Services District for the fiscal year beginning July 1, 2020, as presented by the General Manager, was reviewed, studied and revised by the Board of Directors and represents a responsible and balanced financial approach for the reliable operation and maintenance of the infrastructure and programs under its jurisdiction; and

WHEREAS, the Scotia CSD Board of Directors made the Final Budget for Fiscal Year 2020-2021 available to the public, public meetings were held on April 16, 2020 and May 21, 2020, published notice of a public hearing in a local newspaper to consider the Final Budget for FY 2020-2021, and a public hearing was held on June 18, 2020; and

WHEREAS, the Scotia CSD did, on June 18, 2020 adopt the budget for the fiscal year 2020-2021; and

WHEREAS, the Scotia CSD has reconciled the Mid-Year Actual Revenues and Expenditures since the budget was adopted, and needs to make amendments to the budget to reflect these actual expenditures and revenue conditions.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Scotia Community Services District as follows:

Section 1: The Recitals set forth above are incorporated herein and made an operative part of this Resolution.

Section 2: The budget for fiscal year 2020-2021 is hereby amended as set forth in Exhibit A: "Scotia Community Services District Fiscal Year 2020-2021 Mid-Year Budget Amendment" and is attached hereto and incorporated herein.

Section 3: Modifications and amendments to the 2020-2021 Scotia Community Services District Final Budget shall be allowed during the 2020-2021 fiscal year, when in conformance with Board Policies and state law.

Section 4: This resolution shall be effective upon adoption.

WHEREAS, the Scotia Community Services District Master Fee Schedule will be reviewed on an annual basis and adjusted accordingly; and

WHEREAS, the Board of Directors has determined that it is in the best interest of the District to adopt fees for District services.

NOW, THEREFORE, BE IT RESOLVED:

- 1. The Scotia Community Services District Board of Directors hereby approves establishing fees for District services pursuant to the Master Fee Schedule attached hereto as Exhibit "A" and made a part hereof by this reference.

RESOLUTION NO. 2021-7

A RESOLUTION OF THE SCOTIA COMMUNITY SERVICES DISTRICT BOARD OF DIRECTORSADOPTING THE CONSUMER PRICE INDEX RATE INCREASE IN FEES AND ASSESSMENTS OF 1.5% FOR FY 2021/2022

WHEREAS, the Board of Directors, of the Scotia Community Services District, a political subdivision of and special district in the State of California, sees the need to implement a Consumer Price Index rate increase in fees and assessments of 1.5% for FY 2021/2022; and

WHEREAS, the rates for the Scotia Community Services District were established through a 218 process in 2016 which set a five-year rate schedule that included annual increases to the rates by 1.5% on July 1st of each year through July 1, 2021; and

WHEREAS, the Board of Directors can adopt an increase in fees & assessments to account for inflation as measured by the Consumer Price Index, not to increase 3% in any given year; and

WHEREAS, the 2020 annual Consumer Price Index for the West Region rose 1.5%; and

WHEREAS, the Board of Directors analyzed a budget without the CPI increase with a deficit of -\$1,189,950, and with the CPI increase the deficit decreased down to -\$1,170,833.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors, Scotia Community Services District does hereby adopt the Consumer Price Index rate increase of 1.5% for fees and assessment for FY 2021/2022.
