

RESOLUTION NO. 2022-4

A RESOLUTION OF THE  
SCOTIA COMMUNITY SERVICES DISTRICT BOARD OF DIRECTORS  
TO ADOPT THE FISCAL MID-YEAR 2021-2022 BUDGET AMENDMENT

WHEREAS, the Scotia Community Services District (“Scotia CSD”) is organized and operates pursuant to the California Government Code Section 61000, *et seq.*; and

WHEREAS, the Scotia Community Services District operates on a Fiscal Year beginning on July 1, and ending on June 30, of each year; and

WHEREAS, the Scotia Community Services District Board of Directors is required by California Government Code Section 61110(f) to adopt a final budget on or before June 30<sup>th</sup> of each year; and

WHEREAS, the Final Budget for the Scotia Community Services District for the fiscal year beginning July 1, 2021, as presented by the General Manager, was reviewed, studied and revised by the Board of Directors and represents a responsible and balanced financial approach for the reliable operation and maintenance of the infrastructure and programs under its jurisdiction; and

WHEREAS, the Scotia CSD Board of Directors made the Final Budget for Fiscal Year 2021-2022 available to the public, public meetings were held on April 15, 2021 and May 20, 2021, published notice of a public hearing in a local newspaper to consider the Final Budget for FY 2021-2022, and a public hearing was held on June 19, 2021; and

WHEREAS, the Scotia CSD did, on June 19, 2021 adopt the budget for the fiscal year 2021-2022; and

WHEREAS, the Scotia CSD has reconciled the Mid-Year Actual Revenues and Expenditures since the budget was adopted and needs to make amendments to the budget to reflect these actual expenditures and revenue conditions.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Scotia Community Services District as follows:

Section 1: The Recitals set forth above are incorporated herein and made an operative part of this Resolution.


Section 2: The budget for fiscal year 2021-2022 is hereby amended as set forth in Exhibit A: “Scotia Community Services District Fiscal Year 2021-2022 Mid-Year Budget Amendment” and is attached hereto and incorporated herein.

Section 3: Modifications and amendments to the 2021-2022 Scotia Community Services District Final Budget shall be allowed during the 2021-2022 fiscal year, when in conformance with Board Policies and state law.


Section 4: This resolution shall be effective upon adoption.
