SUBJECT: Approve First Amendment to the River Intake Pump Warranty Agreement between Town of Scotia, LLC, and Scotia Community Services District

### **RECOMMENDATION:**

Consider approving the First Amendment to the Pump Warranty Agreement. The recommended change is to Section 5(a). of the Warranty Agreement the "Warranty Deposit" as referenced in Section 5(a) shall be maintained in a savings account at U.S. Bank, rather than Redwood Capital Bank.

#### **DISCUSSION:**

Following the Board's ratification of the Pump Warrant Agreement, the Town of Scotia notified District staff that the bank referenced in the Agreement for the Warrant Deposit was incorrectly stated. The Town of Scotia is requesting this Amendment to correct the actual bank used by the Town from Redwood Capital Bank to U.S. Bank. All other terms and conditions set forth in the River Intake Pump Warranty agreement shall continue in full force and effect.

### First Amendment To River Intake Pump Warranty Agreement

This FIRST AMENDMENT TO RIVER INTAKE PUMP WARRANTY AGREEMENT (this "First Amendment") is entered into and effective as of September 14, 2023 (the "Effective Date") between TOWN OF SCOTIA COMPANY, LLC, a Delaware limited liability company ("TOS"), and the SCOTIA COMMUNITY SERVICES DISTRICT, a California Community Services District formed pursuant to California Government Code §§ 61000, et seq. ("District"), and constitutes the first amendment to that certain written River Intake Pump Warranty Agreement executed by and between TOS and District, (the "River Intake Pump Warranty Agreement"). TOS and District agree as follows:

- 1. <u>CHANGE TO SECTION 5(a).</u> TOS and District agree that Section 5(a) of the River Intake Pump Warranty Agreement shall be deemed amended as follows: the "Warranty Deposit", as referenced in Section 5.a., shall be maintained in a savings account at U.S. Bank, rather than Redwood Capital Bank, and TOS shall provide the District monthly account statements evidencing that said sum remains on deposit until expiration of the Warranty Period as defined in the River Intake Pump Warranty Agreement.
- 2. <u>CONTINUATION OF AGREEMENT.</u> Except as modified herein, all other terms and conditions set forth in the River Intake Pump Warranty Agreement shall continue in full force and effect.
